LIBRARY REPORT:

Library representative, Linda Myers reported that the Library's vintage book sale raised \$900.00. The library will have a mileage renewal on the November ballot. The Chippewa Branch library hours have expanded to Tuesday, Thursday, & Fridays from 10 a.m. – 5 p.m. and Saturdays from 9 a.m. – 1 p.m. The library book sale that started on May 1st has already raised \$300.00.

The annual pumping is completed. 1 new tank is scheduled for installation. The drainfield has been cleared.

C.L. WEED CONTROL:

PLM has been active on Chippewa Lake with weed control treatments and surveys. Algae seems to be down compared to this time last year.
