# ZONING REQUEST UPDATE:

Chippewa Township Board members attended the February County Commissioners meeting asking for the Commissioners to deny two separate zoning changes within Chippewa Township. Our request fell on deaf ears. The County Commissioners approved both changes; even though it goes against the Mecosta County Building and Zoning Ordinance. The Commissioners allowed a change to property on Dwight Street to LR; which has no rights to a lake, river, or stream.

SECTION 2.16 LR LAKE AND RIVER RESORT DISTRICT A. Intent. To establish and maintain for residential and recreational use those areas with frontage on lakes and rivers and those areas immediately adjacent and associated with the waterfront, which because of their natural characteristics and accessibility to waterfront activities are suitable in a recreational environment; and to further insure the clarity and purity of the water body and waterfront and to protect its economic value and scenic quality.

Mr. Rick Hatkowski, member of the Mecosta County Planning Commission and Chippewa Township resident, stated that he would look into Chippewa Township's issues regarding RV's not hooking into the Sewer System.

#### **NEW OFFICES UPDATE:**

Bryan has received the final drawings. Bryan plans on starting to get estimates next week.

#### **VERIZON UPDATE:**

Ben Herrick, the Building and Zoning Specialist for Verizon contacted Clerk, Kristin on February 17, 2023. We are on the Mecosta County ZBA for a variance for the setback to residential districts on April 3<sup>rd</sup> and we are on the Planning Commission agenda for April 6<sup>th</sup>. There's a 30-day delay for notice from filing so we are on the first of April since we filed last week. Permitting will follow the zoning probably by 30 days.

### **CONSUMERS ENERGY EASEMENT:**

Chippewa Township has been contacted by Brian Moore, Consumer's Energy. They would like us to sign an Easement Agreement for parcel 5403-029-004-400. This Easement is to move two existing power poles and replace them with new poles that are closer to the road.
